Whereas Container Freight Station M/sTake Care Logistics Park (India) Pvt. Ltd. (now known as M/s Hind Terminals Private Limited) located at Village- Palaspe, Mumbai Goa Highway, Taluka- Panvel, Dist. Raigad, Maharashtra-410206 was notified as a Customs Area under Section 8 of the Customs Act, 1962 vide Notification no.29/2015 dt. 15.07.2015 as amended and also appointed as Custodian and Customs Cargo Service Provider vide notification no. 30/2015 dt. 15.07.2015 as amended and whereas name change from M/s Take Care Logistics Park (India) Pvt. Ltd. was approved vide Notification No. 70/2023 dt. 14.08.2023.

2. And whereas, M/s Hind Terminals Private Limited had applied for shifting/ change of CFS from their existing location to new location at **Kalambusare Chirner Road, Chirner Village, Tal. Uran, Dist. Raigad, Maharashtra-410206.**

3. Now, in exercise of the powers conferred on me under Section 8(a) of the Customs Act, 1962, I, B. Sumidaa Devi, Commissioner of Customs (NS-General), Mumbai Customs Zone-II, JNCH, Nhava Sheva, hereby notify the Container Freight Station (CFS) having an area of 87832.0 Sq. Mtr on the land bearing survey Nos. 159/1, 159/3, 159/4A, 159/4B, 159/5, 159/6, 159/7, 159/8, 162/3A, 162/3B, 162/4, 162/6, 162/7, 163/1, 163/2, 170/1, 170/4, 171/2, 171/3, 171/4, 171/6, 173/1, 173/3, 168/5, 170/3A, 170/3B situated at Kalambusare Chirner Road, Chirner Village, Tal. Uran, Dist. Raigad, Maharashtra – 410206, of M/s. Hind Terminals Private Limited as proper place for the purpose of unloading imported goods and loading of export goods or any class of such goods.

4. Further, I, B. Sumidaa Devi, Commissioner of Customs (NS-General), Mumbai Customs Zone-II, JNCH, Nhava Sheva, in exercise of the powers conferred upon me under Section 8(b) of the Customs Act, 1962 hereby specify the limits of the Customs area comprising the

above Container Freight Station location at Kalambusare Chirner Road, Chirner Village, Tal. Uran, Dist. Raigad, Maharashtra-410206 admeasuring 87832.0 SQ MTR, as under
