PUBLIC NOTICE NO.: 07 /2026

Whereas an area admeasuring 2,21,380.29 sqm. of Container Freight Station, M/s Container Corporation of India Limited (A Govt. of India Undertaking under Ministry of Railways), CFS: Dronagiri Rail Terminal, located at Village - Paghote (Dronagiri Node), Sector-2, Plot No. 33, 34 & 35, Taluka Uran, District Raigad, Maharashtra-400707, was notified as a Customs Area under Section 8 of the Customs Act, 1962 vide Notification No. S/5-Gen-48/2003 (P&E) JNCH dated 11.11.2003, as amended and whereas M/s Container Corporation of India Limited (A Govt. of India Undertaking under Ministry of Railways), CFS: Dronagiri Rail Terminal was also appointed as a Custodian for a period of 05 years under Sections 45 of the Customs Act, 1962 vide Public Notice No. 61/2025 dated 21.08.2025, as amended.

And whereas, M/s. Container Corporation of India Limited has requested for denotification of a part of the Customs Area admeasuring 8650 sq. mtrs. located towards the end of South West direction of the Terminal i.e., towards Pagote village end.

Now, therefore, in exercise of the powers conferred upon me under Section 8(a) of the Customs Act, 1962, I, Yashodhan A. Wanage, Pr. Commissioner of Customs (General), Jawaharlal Nehru Customs House, Nhava Sheva, hereby approve denotification of an area of 8650 sq. mtrs. from the approved area of 2,21,380.29 sq. mtrs. as shown in the enclosed layout plan of M/s. Container Corporation of India Limited.

An area admeasuring 2,12,730.29 sq. mtrs. remains notified as Customs Area for the purpose of unloading of imported goods and loading of export goods, and M/s. Container Corporation of India Limited continues to be the custodian of imported cargo till their clearance for home consumption or transhipment and for export cargo brought into the CFS subject to strict compliance with the provisions of the Handling of Cargo in Customs Area Regulations, 2009, the Customs Act, 1962, and other instructions issued by the Government of India or the (Pr.) Commissioner of Customs, JNCH, from time to time.

Further, in exercise of the powers conferred under Section 8(b) of the Customs Act, 1962, I hereby specify the limits of the Customs Area of the CFS, as detailed in the Schedule below. The total area of the CFS, after the above de-notification, becomes 2,12,730.29 sq. mtrs.

- **North Side:** Existing DRT CFS adjacent to Jasai-Uran Railway Line (Central Railway Land) Area is of 1,05,049.01 Sq. Mtrs.
- **South Side:** 36 Mtr CIDCO service road adjacent to Punjab Conware CFS
- **East Side:** Denotified area of DRT CFS admeasuring 13,978 Sq. Mtrs. for DPD containers and plot earmarked by CIDCO for proposed truck terminal near M/s Maersk CFS
- **West Side:** Denotified area of DRT CFS admeasuring 8650 Sq. Mtrs. for Non-Exim business & 36 Mtr CIDCO service road adjacent to Flyover near pagota village
