PUBLIC NOTICE No.- 55/2026

Central Warehousing Corporation, Distripark located at Village Bhendkal, Sector-7, D'Node, Taluka-Uran, District-Raigad, Maharashtra was declared as a Customs Area under Section 8(a) of the Customs Act, 1962 vide Notification dated 24.03.2004 and M/s Central Warehousing Corporation was appointed as the Custodian of the Container Freight Station (CFS) under Section 45 of the Customs Act, 1962 vide Notification F. No. S/06-Misc/4/EPCCell JNCH dated 26.03.2004, which was subsequently renewed vide Notifiction No. 09/2010 , Notification No. 17/2015 dated 15.03.2015 and Public Notice 34/2021 dated 20.04.2021.

2. Now, in exercise of the powers conferred under Section 45(1) and Section 141(2) of the Customs Act, 1962, I, Unmesh Sharad Wagh, Commissioner of Customs (NS-General), Mumbai Customs Zone-II, Nhava Sheva hereby renews the appointment of M/s Central Warehousing Corporation as the 'Custodian' of the imported goods received at the Container Freight Station of M/s Central Warehousing Corporation, Distripark, until the goods are cleared for home consumption or warehoused or transhipped in accordance with the provisions of the Chapter VIII of the Customs Act, 1962. Similarly, M/s Central Warehousing Corporation shall also continue to act as the Custodian of export cargo brought into the said CFS for examination and stuffing till its export through Jawaharlal Nehru Port.

3. Further, in exercise of the powers conferred on me under Regulation 10 of the Handling of Cargo in Customs Areas Regulations, 2009 (HCCAR, 2009), I, Unmesh Sharad Wagh, Commissioner of Customs (NS-General), Mumbai Customs Zone-II, Nhava Sheva hereby renews the approval of **M/s Central Warehousing Corporation as the 'Customs Cargo Service Provider (CCSP)'** for the said CFS M/s Central Warehousing Corporation, Distripark, subject to the following conditions:

- i. The Custodian M/s Central Warehousing Corporation approved as 'Customs Cargo Service Provider' for the said CFS shall abide by all the provisions of the Customs Act, 1962 and the rules of Handling of Cargo in Customs Areas Regulations, 2009, other Regulations, Notifications, Orders issued there under.
- ii. The duration of the renewal of appointment of M/s Central Warehousing Corporation as "Custodian" and "Customs Cargo Service Provider" shall remain for five (05) years from **20.04.2026**.
- iii. The Commissioner of Customs (General), JNCH shall have the right to review the approval as "Customs Cargo Service Provider" before the completion of five years for failure to comply with any of the Regulations of the "Handling of Cargo in Customs Areas Regulations, 2009" or as per the directions of the Government of India.
- iv. The Custodian shall strictly adhere to the 'Handling of Cargo in Customs Areas Regulations, 2009, the Customs Act 1962 and instructions issued by CBIC.
