- V. Copy of S/Bs (ARE-1 in case deemed exports)
- VI. Bank Realization Certificate
- VII. In case third party export (documents as per concerned FTP)

VIII. Other relevant documents submitted to DGFT.

The Bond and Bank Guarantee will be released after the submission of original documents, as detailed above.

4. Further, the licence holders, as detailed in Table-B above, are requested to submit, within 15 days from issuance of this Public Notice, original License and original EODC issued by DGFT for cancellation of Bond and Bank Guarantee as applicable. In the event of failure to submit the aforesaid documents within the stipulated period, the subject Bond and Bank Guarantee as applicable, shall be deemed to be cancelled from the Customs end.

5. It is hereby informed that the bond submitted against the above said EPCG Licences in TSK/JNCH shall be forwarded to EPSMMC, JNCH for placing in concerned file for closure/disposal of EPCG licences.
