Attention of Exporters/Importers/Customs Brokers/Shipping Agents and all concerned is invited to **Public Notice No. 89/2026 dated 22.07.2026** wherein the approval granted to M/s Container Corporation of India Ltd. i.e. CONCOR (A Govt. of India Undertaking, under Ministry of Railways), CFS, Dronagiri Rail Terminal (CONCOR-DRT CFS), located at 35, Dronagiri Node, JNPT Road, Near Paghote, Sector-2, Navi Mumbai – 400 707, as a Customs Cargo Service Provider, was suspended under Regulation 11(2) of HCCAR, 2009, vide Order dated 22.07.2026.

The suspension of M/s Container Corporation of India Ltd. i.e. CONCOR, CFS, Dronagiri Rail Terminal (CONCOR-DRT CFS), under Regulation 11(2) of HCCAR, 2009, has been revoked vide Order dated 11.08.2026. **Accordingly, the approval granted under Public Notice No. 61/2025 dated 21.08.2025 stands restored with effect from the date of issuance of the aforesaid Order.**

3. Accordingly, all stakeholders are informed that normal operations of M/s Container Corporation of India Ltd. i.e. CONCOR, CFS, Dronagiri Rail Terminal (CONCOR-DRT CFS) as a Customs Cargo Service Provider (CCSP) may resume with immediate effect from the date of issuance of the aforesaid Order.
