Sub - Implementation of Shipping Container for Export Cargo to be considered as Unit of Package - reg.

Attention is drawn to Advisory No. 49/2025 dated 11.08.2025 issued by DG Systems, ICES which addresses the treatment of a Shipping Container as a Unit of package (copy attached).

2. In this regard, representations were received from the Trade that the system is considering container as a unit package only in few shipping Bills wherein consignments contain multiple containers and that in most such shipping bills, the system is still selecting packages for examination across containers instead of taking container as a unit of package.

3. The matter was examined by DG Systems. It has been informed that there were some system feature limitations because of which certain instructions were not shared by the RMS to ICES and the same is now being resolved.

4. It has further been informed that while in cases where Annexure C details like seal type, container number etc., are not provided, then NCTC cannot provide instructions to select particular container. Hence, to avail the benefit of facility "Shipping Container for Export cargo to be considered as unit of package for examination", it is necessary that the exporters submit Annexure C at the time of filing SB along with all the requisite details, otherwise system will continue giving instructions in the old manner of selecting packets.

5. Therefore, Exporters are advised to submit complete Annexure C details at the time of filing Shipping Bill for enabling the treatment of Shipping Container as unit of package; otherwise, system will select packages as before. Further, it is informed that ICEGATE will also run a ticker on their website so that the trade is well informed.
