Subject: Restoration of approval granted to M/s International Cargo Terminal Private Limited (ICTPL) as Customs Cargo Service Provider (CCSP) pursuant to Hon'ble CESTAT Final Order No. 85999/2026 dated 10.08.2026 – Reg.

Attention of Exporters/Importers/Customs Brokers/Shipping Agents and all concerned is invited to Public Notice No. 45/2026 dated 13.04.2026, wherein the approval granted to M/s International Cargo Terminal Private Limited (M/s ICTPL) located at Village: Koproli, Tal: Uran, Distt: Raigad, Maharashtra - 410 206, as a Customs Cargo Service Provider, was suspended under Regulation 11(2) of the Handling of Cargo in Customs Areas Regulations, 2009, vide Order dated 13.04.2025 and further order dated 05.05.2026.

2. The suspension of M/s International Cargo Terminal Private Limited (M/s ICTPL), under Regulation 11(2) of HCCAR, 2009, has been restored vide Order dated 18.08.2026. Accordingly, the approval granted under Public Notice No. 67/2023 dated 08.08.2023 **stands restored with effect from 18.08.2026.**

3. Accordingly, all stakeholders are informed that normal operations of M/s International Cargo Terminal Private Limited (ICTPL) as a Customs Cargo Service Provider (CCSP) may resume with immediate effect from the date of issuance of the aforesaid Order.
