**PUBLIC NOTICE NO. 26 / 2026**

The Container Freight Station of M/s Indev Logistics Pvt. Ltd., located at Plot No. 10, Village Somathane, Kone–Savla Rasayani Road, Taluka Panvel, Maharashtra, having an area admeasuring approximately 38,040 Sq. Mtrs., was declared as a Customs Area under Section 8 of the Customs Act, 1962 vide Notification No. 03/2012 dated 14.02.2012. M/s Indev Logistics Pvt. Ltd. was appointed as a Custodian under Section 45 of the Customs Act, 1962 vide Notification No. 01/2012 dated 11.04.2012 and was further appointed as Custodian and Customs Cargo Service Provider under the provisions of under Section 45(1) and 141 (2) of the Customs Act, 1962 and Regulation 10 of the Handling of Cargo in Customs Areas Regulations, 2009 vide Notification No. 07/2014 dated 23.07.2014 for a period of five years w.e.f. 11.04.2012 and was subsequently extended vide CFS Notification No. 03/2017 dated 08.05.2017 till 08.05.2027.

**2.** Subsequently, change of name of the custodian from M/s Indev Logistics Pvt. Ltd. to M/s Kerry Indev Logistics Pvt. Ltd. was approved on 08.08.2017. Now, M/s Kerry Indev Logistics Private Limited has sought approval for change of name to M/s Indev Infra Private Limited, without any change in ownership, shareholding pattern or management control.

**3.** The proposal for the change of name is hereby approved and accordingly, Notification No. 03/2012 dated 14.02.2012 and CFS Notification No. 03/2017 dated 08.05.2017 issued under Section 45(1) and 141 (2) of the Customs Act, 1962 and Regulation 10 of Handling of Cargo in Customs Areas Regulations, 2009 are hereby amended to the extent of change of name of the CFS as **M/s Indev Infra**

**Private Limited** from the date of issue of this Public Notice.
