Subject: Extension of the validity of Public Notice No. 59/2026 dated 26.05.2026 declaring the temporarily expanded land parcel admeasuring 9.22 acres at the Centralized Parking Plaza (CPP) as a Customs Area under Section 8(a) of the Customs Act, 1962 for storage of Direct Port Delivery (DPD) import goods.

1. Attention is invited to **Public Notice No. 59/2026 dated 26.05.2026**, whereby, in exercise of the powers conferred under Section 8(a) of the Customs Act, 1962, I, Umesh Sharad Wagh, Commissioner of Customs (General), Jawaharlal Nehru Custom House (JNCH), Nhava Sheva, declared the land parcel admeasuring 9.22 acres, situated at the Centralized Parking Plaza (CPP), JNPA, as a Customs Area for the storage of Direct Port Delivery (DPD) import goods on a temporary basis.
2. In continuation of the aforesaid Public Notice and in exercise of the powers conferred under Section 8(a) of the Customs Act, 1962, I, Umesh Sharad Wagh, Commissioner of Customs (General), JNCH, Nhava Sheva, hereby extend the validity of the temporary declaration of the aforesaid Customs Area up to **31.10.2026**.
3. The rest of the terms and conditions stipulated in **Public Notice No. 59/2026 dated 26.05.2026** shall continue to govern the operation of the aforesaid Customs Area and shall remain unchanged. The Custodian shall continue to comply with all the conditions prescribed therein throughout the extended period of validity.
