Attention of all concerned officers is invited to the Hazardous Waste (Management Handling) and Trans Boundary Movement Rules, 2008. These Rules have been enacted by the Ministry of Environment and Forests, Government of India, in exercise of powers conferred on them by Section 6,8 and 25 of the Environment Protection Act, 1986 (29 of 1986), and in suppression of the Hazardous Waste (Management and Handling) Rules 1989. Accordingly the following procedure is laid in compliance to the Rule 16 of the said Rules, ibid.

- 2. Form 9, which is a Trans boundary Movement Document filled by the Importer / Exporters, should be submitted to the Examining Officer in duplicate, at the time of examination of consignments of Paper Waste.
- 3. The Examining officer will counter sign the original copy of the Form 9, and retain the same along with the Docket containing BE, invoice and other documents. The signed duplicate copy of the Form 9, will be handed over to the importer.
- 4. Random samples which are to be drawn as per Rule 16 (6) of the Rules, should be done as per the standing order No. 17/2009. The validity of the sample will be for two years.
- 5. Debiting of DGFT licence and verification of MOEF permission will be done by the Group.
- 6. Pre-shipment test analysis of the hazardous waste consignment from a laboratory accredited in the exporting country should be submitted to the Group,

the Group will counter sign the same, which will be submitted by the importer at the time of examination to the examining officer.

7. In case the consignment is found to contain any Hazardous Waste, the BE will be referred to the group for Adjudication, and re-export of the consignment to the exporting country.
