Standing Order No. 10 /2025

Sub:-Approval for Open Examination for RMS Facilitated Shipping Bills- Amendment to the Standing Order No. 06/2014 dated 15.05.2014-reg.

Reference is invited to instruction at Para 10 of Standing Order No. 06/2014 dated 15.05.2014 issued by Commissioner of Customs (Export), JNCH, the same are reproduced below for reference-

"Examination: The examination of all RMS interdicted bills shall be carried out as per the instructions communicated by the RMS and the assessing officer's examination instructions. Certain SBs may be directly routed by the RMS for examination without any assessment by officers. In such cases, the RMS instructions for examination should be treated as examination orders. The officers shall bear in mind all existing standing orders and circulars issued by the department, while performing their work. The examining officers must ensure that the goods under examination tally with the declared description, including critical parameters like brand, model, make, number, specification, grade, purity, configuration, capacity, denier etc., which may have a direct bearing on valuation, benefits under Export Promotion schemes and classification etc. The examination of the goods and Let Export Order (LEO) shall be completed by the officers, only after ensuring that the compulsory compliance requirements (CCRs) mentioned in the RMS instructions are duly complied with. Whenever the Officers examining the cargo feel that the CCRs figuring on their screen are not applicable to any specific SB/ item, they must enter a departmental comment in the SB in the EDI specifying the reasons thereof before giving clearance. It is also clarified that officers in the shed may examine a consignment even if it is facilitated and directly selected for LEO by the RMS, if they have a valid reason for doing so. However, such examination should be done only after prior approval of the Commissioner or an officer authorized by him for this purpose, who shall not be below the rank of Additional/Joint Commissioner of Customs and after recording the reasons for the same. A brief remark on the reasons and particulars of Commissioner's authorization shall be made by the officer examining the goods in the departmental comments in the EDI system."

2. In view of the above instructions, approval of Commissioner is being sought for examination for facilitated Shipping Bills even in cases where examination of export goods is statutorily prescribed.

3. Reference is invited to the following cases wherein the identity of the goods is statutorily required to be established by way of examination of export goods and the procedure prescribed vide Public Notice No. 78/2017 dated 21.06.2017 have to be followed:

- i. Re-export of goods under Section 69 of Customs Act, 1962;
- ii. Re-export of goods under Section 74 of Customs Act, 1962;
- iii. Re-export of goods imported under reward scheme as specified under Chapter 3 of Foreign Trade Policy;
- iv. Re-export of goods imported under advance authorization scheme as specified under Para 2 of Notification No. 96/2009-Cus., dated 11-9- 2009 as amended;
- v. Re-export of imported goods imported under Notification No 158/95-Customs, dated 14.11.1995 as amended;
- vi. Re-export of goods imported under ATA Carnet.

4. It is hereby clarified that In all such cases referred to Para 3 above, wherein identity of the goods under re-export is to be established w.r.t imported goods to the satisfaction of AC/DC Docks, there is no requirement of seeking separate approval other than that of AC/DC Docks.

5. Standing Order No. 06/2014 dated 15.05.2014 issued by Commissioner of Customs (Export), JNCH is amended to the extent as above.

6. Difficulties if any faced by the officers in implementation of the above Standing Order may be brought to the notice of the Additional Commissioner of Customs, Export Docks, NS-II.
