

DPD Process at NSICT

1. Once the customer has got the DPD code from terminal, they have to share this unique code with their respective Shipping line in order to nominate their boxes for Direct delivery in Import advance list (IAL).
2. Customer has to submit the Delivery Order received from Shipping Line along with the Challan & Out of Charge to our Documentation desk to get the container released, Scanned copy of same also can be sent thru the designated email id to avoid physical movement inside the Terminal.
3. E gate pass (Import E form-13) must be provided by the Line to the customer.
4. Registered Trailers can come to the gate with our E gate pass and will be allowed to take the delivery; you can get your trailer registered with Terminal at our Parking Plaza.
5. Once the container is discharged from vessel, customer has to take the delivery within 48 hours as per the Custom's Guideline.
6. If they fail to take delivery within the stipulated time, then the container will be moved to Speedy Multimodes (CFS) as mentioned in JNCH PN No. 08/2017 dated: 16.01.2017. The Shipping line will be intimated accordingly. All outstanding charges pertaining to the services rendered post discharge of container and stacking in NSICT/NSIGT will be recovered by Speedy Multimodes on behalf of NSICT/NSIGT. The charges applicable will be calculated as per those mentioned in this document.
7. Customer can retain their boxes at Terminal for DPD even after 48 hours by sending a prior request to hold the boxes inside the Terminal.
8. Invoice will be sent to the registered email Id once the container is delivered and the charges will be deducted from their respective PDA.
9. Customer has to ensure that they have sufficient amount in their PDA account as per the below table, three working days prior to vessel arrival (excluding weekends).

Please note: Free period for Import Ground rent is 3 days at NSICT after that charges will be applicable as per below.

Following charges are applicable for Reefer boxes.

Reefer Plug-in Charges/Slab for every 4 hours	
Size	NSICT
20'	\$8.90
40'	\$13.36

Exchange rate will be based on SBI buying rate of US Dollars on the date of entry inward of vessel in to the terminal for import containers.

Reefer plug-in charges are applicable every 4 hours. Ground rent also will be applicable simultaneously.

Please note: all the above charges are subject to applicable Government Taxes.
