Tender documents must be placed in an envelope securely, sealed and distinctly marked "TENDER FOR SUPPLY" and be addressed above address. Tender enquiry reference and due date and time of opening must be boldly on the envelope. Envelopes be clearly marked as Techno-Commercial Price bids respectively with tender enquiry reference, due date and due time. These two envelopes should be put in one envelope and marked to The Chemical Examiner Director, Custom House Laboratory, J.N.Custom House, Nhava Sheva – 400707, Tal. – Uran, Distt. (Maharashtra). Tender enquiry reference with due date and due time should be on outer cover.
2. Unsolicited quotations/quotations received late or improperly sealed or with incomplete marking or with unattested overwriting/corrections in the quotation documents are liable to be rejected.
3. Items supplied are subject to inspection and acceptance and the supplier should collect rejected items at his cost.
4. Validity: 180 days from the date of opening.
5. No correspondence/discussions/visits whatsoever will be entertained on the subject unless specifically called by this office after opening the tenders for technical discussions/ price negotiations. Any violation of this will render the quotations invalid and the firm is liable to be blacklisted.

6. This office reserves the right to call for techno-commercial/price negotiations. The company should depute competent representative for such discussion/negotiations whenever called for and he shall be competent to take on the spot decisions.

7. Drawings/specifications sent along with this letter should be returned along with your quotation or regret letter.
