Terms & Conditions

1. The vendor/firm shall quote item-wise rates as well as the total amount for the complete work.
2. The quantities mentioned in the scope of work are tentative and may vary as per actual site requirements.
3. The quoted rates shall be inclusive of all charges such as labour, materials, transportation, loading/unloading, tools, tackles, taxes, duties, GST and other incidental charges. GST, if any, shall be clearly mentioned separately.
4. Interested vendors may visit/inspect the site during office hours on working days before submitting the quotation. No claim on account of site conditions shall be entertained after submission of quotation.
5. The work shall be carried out strictly as per the requirement of this office and to the satisfaction of the competent authority/user section.
6. The materials used for the work shall be of good quality/standard make, and the vendor/firm shall ensure proper workmanship.
7. The work shall be completed within **10 days** from the date of issuance of the work order.
8. The vendor/firm shall be responsible for cleaning the site and removing debris/waste material generated during execution of the work.
9. The vendor/firm shall ensure that no damage is caused to Government property during execution of the work. Any damage caused shall be repaired/replaced by the vendor/firm at its own cost.
10. The vendor/firm shall follow all necessary safety precautions during execution of the work and shall be responsible for the safety of its workers/labourers.
11. Payment shall be made based on actual measurements of work executed and verified by the department, after satisfactory completion of the work and submission of bill/invoice, subject to deduction of applicable taxes/statutory dues as per rules.
12. The quotation received after the prescribed date/time shall not be considered.
13. The lowest quotation shall not automatically confer any right for award of work. The decision of the competent authority shall be final and binding.
14. The department reserves the right to accept or reject any or all quotations without assigning any reason thereof.
