1. Name of Work

Cutting and removal of grass, shrubs and dense vegetation, including disposal of all debris, at the Departmental Township Quarters, Phunde Village, Uran.

2. Scope of Work

- Cutting and removal of grass, shrubs, and dense vegetation around the constructed buildings including front and rear sides up to a distance of 3 meters.
- Clearing vegetation along the internal approach road within the township premises.
- Removal and safe disposal of all cut grass, foliage, shrubs, and debris from the premises.
- Total approximate area: **25,300 sq. meters.**
