During post clearance audit of the Bills of Entry pertaining to the importer M/s Xiaomi Technology India Private Limited, it was noticed that the imported items self-declared as "Mi Smart Speaker", have been classified under CTH 85176290 and paid BCD @10% by availing benefit under Sl. No. 20 of Notification No. 57/2017 - Customs.

- It is seen from the Customs Tariff Act, 1975 that the heading 8517 adopted by the importer 2. covers "Telephone sets, including telephones for cellular networks or other wireless networks; other apparatus for the transmission or reception of voice, images or other data, including apparatus for communication in a wired or wireless network (such as a local or wide area network)...". The goods imported self-declared as "Mi Smart Speakers", are a type of Loudspeakers and do not perform the functions of reception and transmission of voice, images or other data. Hence, the goods are appropriately classifiable under CTH 85182900 attracting BCD@ 15%. Heading 8518 covers "...Loudspeakers, whether or not mounted in their enclosures; Headphones and earphones, whether or not combined with a microphone, and sets consisting of a microphone and one or more loudspeakers; ...".
- Subsequent to issue of Audit Consultative latter, frecal very of duty with interest has been made from the said importer. Received
