CFS NOTIFICATION No.13/2012

The area admeasuring 90,066 Sq. Mtr. (9.0066 Ha.) of Container Freight Station M/s. Ameya Logistics Pvt. Ltd., Container Freight Station (CFS) situated at village Dhasakoshi, Taluka Uran, Dist. Raigad, Maharashtra was declared a Customs Area under Section 8 of the Customs Act, 1962 vide Notification No. 05/2007 dated 06.06.2007 and 02/2011 dated 08.04.2011 and M/s. Ameya Logistics Pvt. Ltd. was appointed as Custodian and a Customs Cargo Service Provider for that area vide Notification No. 06/2007 dated 06.06.2007 and 03/2011 dated 08.04.2011 issued under Section 45 (1) and 141 (2) of the Customs Act, 1962.

Further, an additional area of land of 46637 Sq. Mtrs. (4.6637 Ha.) of M/s. Ameya Logistics Pvt. Ltd. and forming part of the said CFS and located adjacent to the above CFS has been declared as Customs Area vide Notification No.13 /2012 dated 30.10.2012 for the purpose of storage, stuffing, destuffing and clearance of Export/Import cargo.

Now, in exercise of the powers conferred on me by Section 45 (1) and 141(2) of the Customs Act, 1962, I Manoj Krishna, Commissioner of Customs (Export), Jawaharlal Nehru Custom House, Mumbai Zone II, Nhava Sheva hereby appoint M/s. Ameya Logistics Pvt. Ltd. to be the Custodian of the Imported goods received at the Container Freight Station of M/s. Ameya Logistics Pvt. Ltd. admeasuring total area of 13,67,03 Sq. Mtrs.(13.6703 Ha.), until these are cleared for home consumption or are warehoused or are transshipped in accordance with the provision of chapter VIII of the Customs Act, 1962. Similarly, M/s. Ameya Logistics Pvt. Ltd. will also be Custodian of the export cargo brought into said Container Freight Station for examination and stuffing till their exportation through Jawaharlal Nehru Port. Further, in exercise of the powers conferred on me under Regulation 10(1) of Handling of Cargo in Customs Area Regulation, 2009, I hereby approve the Custodian M/s. Ameya Logistics Pvt. Ltd. **as a Customs Cargo Service Provider for the said CFS M/s. Ameya Logistics Pvt. Ltd. subject to the following conditions:**

1. The Custodian approved as a Customs Cargo Service Provider shall abide by all the provisions of the Customs Act, 1962 and the Rules, Handling of Cargo in Customs Area Regulation 2009, other Regulations, Notifications and orders issued there under.
2. The duration of appointment of M/s. Ameya Logistics Pvt. Ltd. as Custodian and duration of approval as Customs Cargo Service Provider shall initially remain for five years from 19.01.2010 (date of issues of previous Notification 04/2010 dated 19.01.2010). The Commissioner of Customs (Export) shall have the right to review the approval as Customs Cargo

Service Provider before the completion of five years for failure to comply with any of the Regulations of “Handling of Cargo in Customs Area Regulations, 2009.
