CFS NOTIFICATION No.14 /2012

The area admeasuring 76614.46 Sq. Mtr. (7.6614 Ha.) of Container Freight Station M/s. Navkar Corporation Pvt Ltd Container Freight Station (CFS) situated at village Somatane, Panvel, Uran, Dist. Raigad, Maharashtra was declared a Customs Area under Section 8 of the Customs Act, 1962 vide Notification No. 06/2009 dated 11.05.2009 as amended by Notification No. 29/2010 dated 02.08.2010, No. 04/2011 dated 28.04.2011 and No. 06/2012 dated 24.05.2012 and M/s. Navkar Corporation Pvt Ltd was appointed as Custodian and a Customs Cargo Service Provider for that area vide Notification No. 05/2009 dated 11.05.2009 and 05/2011 dated 28.04.2011 issued under Section 45 (1) and 141 (2) of the Customs Act, 1962.

Further, an additional area of land of 27773.04 Sq. Mtrs. (2.7773 Ha.) of M/s. Navkar Corporation Pvt Ltd and forming part of the said CFS and located adjacent to the above CFS has been declared as Customs Area vide Notification No.14/2012 dated 07.11.2012 for the purpose of storage, stuffing, destuffing and clearance of Export/Import cargo.

Now, in exercise of the powers conferred on me by Section 45 (1) and 141(2) of the Customs Act, 1962, I Manoj Krishna, Commissioner of Customs (Export), Jawaharlal Nehru Custom House, Mumbai Zone II, Nhava Sheva hereby appoint M/s. Navkar Corporation Pvt Ltd to be the Custodian of the Imported goods received at the Container Freight Station of M/s. Navkar Corporation Pvt Ltd admeasuring total area of 104387.50 Sq. Mtrs.(10.4387 Ha.), until these are cleared for home consumption or are warehoused or are transshipped in accordance with the provision of chapter VIII of the Customs Act, 1962. Similarly, M/s. Navkar Corporation Pvt Ltd will also be Custodian of the export cargo brought into said Container Freight Station for examination and stuffing till their exportation through Jawaharlal Nehru Port. Further, in exercise of the powers conferred on me under Regulation 10(1) of Handling of Cargo in Customs Area Regulation, 2009, I hereby approve the Custodian M/s. Navkar Corporation Pvt Ltd **as a Customs Cargo Service Provider for the said CFS M/s. Navkar Corporation Pvt Ltd subject to the following conditions:**

1. The Custodian approved as a Customs Cargo Service Provider shall abide by all the provisions of the Customs Act, 1962 and the Rules, Handling of Cargo in Customs Area Regulation 2009, other Regulations, Notifications and orders issued there under.
2. The duration of appointment of M/s. Navkar Corporation Pvt Ltd as Custodian and duration of approval as Customs Cargo Service Provider shall remain for five years from 11.05.2009 (date of issues of previous Notification 29/2010 dated 02.08.2010). The Commissioner of Customs (Export) shall have the right to review the approval as Customs Cargo Service Provider before

the completion of the said five years for failure to comply with any of the Regulations of
“Handling of Cargo in Customs Area Regulations, 2009.
