CFS NOTIFICATION NO.15/2015

The area admeasuring 15 acres (i.e. 60878 SQM aprox.) Of Container Freight Station situated at Somathane Village, Taluka Panvel, Maharashtra of M/s. Apollo Logisolutions Ltd. was declared as a Customs Area under Section 8 of The Customs Act, 1962 vide Notification no 15/2009 dated 30.07.2009. M/s. Apollo Logisolutions Ltd. was appointed as a 'Custodian' & 'Customs Cargo Service Provider' for the said CFS area vide notification no. 08/2011 dated 29.07.2011. Further, an additional area of 20339 SQM was notified as a 'Customs Area' under Section 8 of The Customs Act, 1962 vide Notification no 14/ 2015 dated 31.03.2015. Thus the total CFS area becomes 81,217 SQM.

Now, in exercise of the powers conferred on me under Section 45(1) and 141 (2) of the Customs Act, 1962, I, S.H. Hasan, Commissioner of Customs (General), Jawaharlal Nehru Custom House, Mumbai Zone-II, Nhava Sheva hereby appoint M/s. Apollo Logisolutions Ltd. to be the Custodian of the imported goods received at their Container Freight Station until these are cleared for home consumption or are warehoused or are transshipped in accordance with the provision of Chapter VIII of the Customs Act , 1962. Similarly, M/s. Apollo Logisolutions Ltd. will also be the Custodian of the Export Cargo brought into said Container Freight Station, including the additional area, for examination and stuffing till their exportation through Jawaharlal Nehru Port.

Further, in exercise of the powers conferred on me under Regulation 10 of the "Handling of Cargo in Customs Areas Regulations 2009". I, S.H. Hasan, Commissioner of Customs (General) hereby approve M/s. Apollo Logisolutions Ltd. as a 'Customs Cargo Service Provider' for the abovementioned Container Freight Station of M/s. Apollo Logisolutions Ltd., including the additional area, subject to following conditions:

4.The Custodian M/s. Apollo Logisolutions Ltd. approved as "Customs Cargo Service Provider" for the said CFS shall abide by all the provisions of The Customs Act, 1962 and the rules of the "Handling of Cargo in Customs Areas Regulations 2009", other regulations, notifications, orders issued there under.

5.The duration of the appointment of M/s. Apollo Logisolutions Ltd.. as ‘Custodian’ and as the ‘Customs Cargo Services Provider’ shall remain for five (5) years from the date of issue of the original notification no 08/2011 dated 29.07.2011.

6.The Commissioner of Customs (General) shall have the Right to review the approval as ‘Customs Cargo Services Provider’ anytime for failure to comply with any of the Regulations of the “Handling of Cargo in Customs Areas Regulations 2009 or as per the directions of the Government of India.
