NOTIFICATION NO. 03 / 2016

The area located inside the Jawaharlal Nehru Port, Taluka – Uran, Distt. Raigad, Maharashtra of M/s. Nhava Sheva (India) Gateway Terminal Pvt. Ltd. has been declared as a Customs Area under Section 8 of the Customs Act, 1962 vide Notification Nos. 07/2015 dated 04.03.2015, No. 31/2015 dated 17.07.2015.

Further, an additional area of 231168.912 Sqm (developed as a Standalone Container Handling Facility) adjacent to the above notified area, has been notified as Customs Area under Section 8 of the Customs Act, 1962 vide Notification No. 02/2016 dated 29.06.2016.

Now, in exercise of the powers conferred on me under Section 45 (1) and 141 (2) of the Customs Act, 1962, and in supersession of Notification No. 32/2015 dated 17.07.2015, I, Rajeev Tandon, Principal Commissioner of Customs (General), Jawaharlal Nehru Custom House, Mumbai Zone – II, Nhava Sheva hereby appoint M/s. Nhava Sheva (India) Gateway Terminal Pvt. Ltd. to be the Custodian of the imported goods received in the above mentioned entire area (notified as Customs Area vide Notification Nos. 07/2015 dated 04.03.2015, 31/2015 dated 17.07.2015 and 02/2016 dated 29.06.2016), within the standalone container handling facility with a Quay length of 330 M of M/s. Nhava Sheva (India) Gateway Terminal Pvt. Ltd. located inside the Jawaharlal Nehru Port, Taluka-Uran, Distt. – Raigad, Maharashtra until these are delivered to the CFSs or are transhipped in accordance with the provision of Chapter VIII of the Customs Act, 1962. Similarly, M/s. Nhava Sheva (India) Gateway Terminal Pvt. Ltd. will also be the Custodian of the Export Cargo brought into said notified area, till their exportation through Jawaharlal Nehru Port.

Further, in exercise of the powers conferred on me under Regulation 10 of the “Handling of Cargo in Customs Areas Regulations 2009”, I, Rajeev Tandon, Principal Commissioner of Customs (General), hereby appoint M/s. Nhava Sheva (India) Gateway Terminal Pvt. Ltd. as a ‘Customs Cargo Services Provider’ for the above mentioned entire area (notified as Customs Area vide Notification Nos. 07/2015 dated 04.03.2015, 31/2015 dated 17.07.2015 and 02/2016 dated 29.06.2016), within the standalone container handling facility with a Quay length of 330 M of M/s. Nhava Sheva (India) Gateway Terminal Pvt. Ltd. . located inside the Jawaharlal Nehru Port, Taluka-Uran, Distt. – Raigad, Maharashtra, subject to following conditions:

- The Custodian M/s. Nhava Sheva (India) Gateway Terminal Pvt. Ltd. approved as Customs Cargo Services Provider for the said entire notified area shall abide by all the provisions of the Customs

Act, 1962 and the rules of the “Handling of Cargo in Customs Areas Regulations 2009”, other Regulations, Notifications, Orders issued there under.

- The duration of the appointment of M/s. Nhava Sheva (India) Gateway Terminal Pvt. Ltd. as ‘Custodian’ and as the ‘Customs Cargo Services Provider’ shall remain for two (2) years from the date of issue of this Notification.

The Principal Commissioner of Customs (General) shall have the Right to review the approval as ‘Customs Cargo Services Provider’ before the completion of two years for failure to comply with any of the Regulations of the “Handling of Cargo in Customs Areas Regulations 2009” or as per the directions of the Government of India.
