## **NOTIFICATION NO.05/2015**

The area admeasuring 8.5 acres of Container Freight Station of M/s. JWC Logistics Park Pvt Ltd. located at Village Palaspe, Mumbai- Goa Road, Panvel, Dist. Raigad, Maharashtra was declared as a Customs Area under section 8 of the Customs Act, 1962 vide notification No. 17/2006 dated 19.05.2006 and M/s. JWC Logistics Park Pvt Ltd was appointed as a Customs Cargo Service Provider for that area vide notification No. 18/2006 dated 19.05.2006 and 02/2009 dated 12.01.2010. Vide notification no. 13/2010 dated 21.04.2010 an additional area of 3.5 acres was also declared as Customs area and M/s. JWC Logistics Park Pvt Ltd. was appointed as a Customs Cargo Service Provider for the total area admeasuring 12 acres vide Notification No. 14/2010 dated 21.04.2010 for a duration of 5 years from the date of issue of previous notification 02/2009 i.e. 12.01.2010, under the provisions of “Handling of Cargo in Customs Areas Regulations 2009”.

Now, in exercise of the powers conferred on me under section 45 (1) and 141 (2) of the Customs Act, 1962, I, S.H. Hasan, Commissioner of Customs (General), Jawaharlal Nehru Custom House, Mumbai Zone II, Nhava Sheva hereby appoint M/s. JWC Logistics Park Pvt Ltd. to be the ‘Custodian’ of the Imported goods received at the Container Freight Station of M/s. JWC Logistics Park Pvt Ltd. until these are cleared for home consumption or are warehoused or are transhipped in accordance with the provisions of Chapter VIII of the Customs Act, 1962. Similarly, M/s. JWC Logistics Park Pvt Ltd. will also be the ‘Custodian’ of the Export cargo brought into said Container Freight Station for examination and stuffing till their exportation through Jawaharlal Nehru Port.

Further, in exercise of the powers conferred on me under Regulation 10 of the “Handling of Cargo in Customs Area Regulations, 2009”, I, S.H. Hasan Commissioner of Customs (General) hereby approve M/s. JWC Logistics Park Pvt Ltd.. as a “Customs Cargo Service Provider” for the said CFS M/s. JWC Logistics Park Pvt Ltd. subject to following conditions:

1.The Custodian M/s. JWC Logistics Park Pvt Ltd. approved as Customs Cargo Service Provider for the said CFS shall abide by all the provisions of the Customs Act, 1962 and the rules of the “Handling of Cargo in Customs Area Regulations, 2009”, other regulations, notifications, orders issued there under.

2.The duration of the appointment of M/s. JWC Logistics Park Pvt Ltd.. as ‘Custodian’ and as “Customs Cargo Service Provider” shall remain for five (5) years from 12.01.2015.

3.The Commissioner of Customs (General) shall have the Right to review the approval as ‘Customs Cargo Service Provider’ before the completion of five years for failure to comply with any of the regulations of the “Handling of Cargo in Customs Area Regulations, 2009”.
