NOTIFICATION NO. 09 /2014

The area admeasuring 1,35,156 Sq. Feet of Container Freight Station of M/s Navkar Corporation Ltd.- I located at Survey No. 137/1A/1, At new Ajiwali Village, old Mumbai Pune NH4, Tal. Panvel, Distt. Raigad, Maharashtra was declared as a Customs Area under Section 8 of The Customs Act, 1962 vide Notification no 02/2008 dated 12.05.2008, and M/s Navkar Corporation Ltd. -I was appointed as a Custodian and the Customs Cargo Service Provider for that area vide notification 01/2008 dated 12.05.2008 for 5 years under section 45(1) of The Customs Act, 1962 which was extended till 09.11.2014 vide notification no 17/2009 dated 10.11.2009.

Now, in exercise of the powers conferred on me under Section 45(1) and 141 (2) of the Customs Act, 1962, I, S.H. Hasan, Commissioner of Customs (Export), Jawaharlal Nehru Custom House, Mumbai Zone II, Nhava Sheva hereby appoint M/s Navkar Corporation Ltd. - I to be the 'Custodian' of the imported goods received at the Container Freight Station of M/s Navkar Corporation Ltd. - I until these are cleared for home consumption or are warehoused or are transshipped in accordance with the provisions of Chapter VIII of the Customs Act , 1962. Similarly, M/s Navkar Corporation Ltd. - I will also be the 'Custodian' of the Export Cargo brought into said Container Freight Station for examination and stuffing till their exportation through Jawaharlal Nehru Port.

Further, in exercise of the powers conferred on me under Regulation 10 of the "Handling of Cargo in Customs Areas Regulations 2009". I, S.H. Hasan, Commissioner of Customs (Export) hereby approve M/s Navkar Corporation Ltd. - I as a 'Customs Cargo Services Provider' for the said CFS M/s Navkar Corporation – I Ltd. subject to following conditions:

 The Custodian M/s Navkar Corporation Ltd. - I approved as Customs Cargo Services Provider for the said CFS shall abide by all the provisions of The Customs Act, 1962 and the rules of the "Handling of Cargo in Customs Areas Regulations 2009", other regulations, notifications, orders issued there under.

 The duration of the appointment of M/s Navkar Corporation Ltd. - I as 'Custodian' and as the 'Customs Cargo Services Provider' shall remain for five (5) years from 09.11.2014.

 The Commissioner of Customs (Export) shall have the Right to review the approval as 'Customs Cargo Services Provider' before the completion of five years for failure to comply with any of the Regulations of the "Handling of Cargo in Customs Areas Regulations 2009.
