1. M/s. Forbes & Company Ltd. was appointed as ‘Custodian’ under section 45(1) of the Customs Act, 1962 vide notification No. 02/2007 dated 26.03.2007. Further, in view of HCCAR-2009, vide Notification No. 16/2010 dated 12.03.2010, M/s. Forbes & Company Ltd. was again appointed as Custodian and “Customs Cargo Service Provider” for total area of 60,650 sq.mt. for duration of 5 years.

2. Now, in exercise of the powers conferred on me under section 45 (1) and 141 (2) of the Customs Act, 1962, I, S.H. Hasan, Commissioner of Customs (General), Jawaharlal Nehru Custom House, Mumbai Zone II, Nhava Sheva hereby appoint M/s. Forbes & Company Ltd. to be the ‘Custodian’ of the Imported goods received at the Container Freight Station of M/s. Forbes & Company Ltd. until these are cleared for home consumption or are warehoused or are transhipped in accordance with the provisions of Chapter VIII of the Customs Act, 1962. Similarly, M/s. Forbes & Company Ltd. will also be the ‘Custodian’ of the Export cargo brought into said Container Freight Station for examination and stuffing till their exportation through Jawaharlal Nehru Port.

3. Further, in exercise of the powers conferred on me under Regulation 10 of the “Handling of Cargo in Customs Area Regulations, 2009”, I, S.H. Hasan Commissioner of Customs (General) hereby approve M/s. Forbes & Company Ltd. as a **“Customs Cargo Service Provider” for the said CFS M/s. Forbes & Company Ltd. subject to following conditions:**

4. The Custodian M/s. Forbes & Company Ltd. approved as “Customs Cargo Service Provider” for the said CFS shall abide by all the provisions of the Customs Act, 1962 and the rules of the “Handling of Cargo in Customs Area Regulations, 2009”, other regulations, notifications, orders issued there under.

5. The duration of the appointment of M/s. Forbes & Company Ltd. as ‘Custodian’ and as “Customs Cargo Service Provider” shall remain for five (5) years from 12.03.2015.

6. The Commissioner of Customs (General) shall have the Right to review the approval as ‘Customs Cargo Service Provider’ before the completion of five years for failure to comply with any of the regulations of the “Handling of Cargo in Customs Area Regulations, 2009”.
