NOTIFICATION NO. 13/2014

The area admeasuring 46,111 Sq Mtrs of Container Freight Station of M/s Ashte Logistics Pvt Ltd located at Village Ashte, Taluka Panvel, Dist. Raigad, Maharashtra was declared as a Customs Area under section 8 of the Customs Act, 1962 vide notification no. 19/2013 dated 07.02.2013, and M/s Ashte Logistics Pvt Ltd was appointed as a Custodian and the Customs cargo Service Provider for that area vide notification 20/2013 dated 07.02.2013 for a duration of 5 years as declared initially in notification no. 02/2009 i.e. from 13.01.2009.

Now, in exercise of the powers conferred on me under section 45 (1) and 141 (2) of the Customs Act, 1962, I, S.H. Hasan, Commissioner of Customs (General), Jawaharlal Nehru Custom House, Mumbai Zone II, Nhava Sheva hereby appoint M/s Ashte Logistics Pvt Ltd to be the ‘Custodian’ of the Imported goods received at the Container Freight Station of M/s Ashte Logistics Pvt Ltd until these are cleared for home consumption or are warehoused or are transshipped in accordance with the provisions of Chapter VIII of the Customs Act, 1962. Similarly, M/s Ashte Logistics Pvt Ltd will also be the ‘Custodian’ of the Export cargo brought into said Container Freight Station for examination and stuffing till their exportation through Jawaharlal Nehru Port.

Further, in exercise of the powers conferred on me under Regulation 10 of the “Handling of Cargo in Customs Area Regulations, 2009”, I, S.H. Hasan Commissioner of Customs (General) hereby approve M/s Ashte Logistics Pvt. Ltd. as a ” Customs cargo Service Provider” for the said CFS M/s Ashte Logistics Pvt Ltd subject to following conditions

1. The Custodian M/s Ashte Logistics Pvt Ltd approved as Customs cargo Service Provider for the said CFS shall abide by all the provisions of the Customs Act, 1962 and the rules of the “Handling of Cargo in Customs Area Regulations, 2009”, other regulations, notifications, orders issued there under.
2. The duration of the appointment of M/s Ashte Logistics Pvt Ltd as ‘Custodian’ and as “Customs cargo Service Provider” shall remain for five (5) years from 20.11.2014.
3. The Commissioner of Customs (General) shall have the Right to review the approval as ‘Customs cargo Service Provider’ before the completion of five years for failure to comply with any of the regulations of the the “Handling of Cargo in Customs Area Regulations, 2009”.
