NOTIFICATION NO. 14 /2014

The area admeasuring 29.8 Hectors of Container Frieght Station Logistic Park. located at village Bhendkhal, Sector -10, Dronagiri Node, Taluka Uran, Dist Raigad, Maharashtra was declared as a Customs Area under Section 8 of The Customs Act, 1962 vide Notification nos 13/2009 dated 09.07.2009 & 03/2007 dated 09.04.2007 and M/s. Central Warehousing Corporation was appointed as a Custodian and the Customs Cargo Service Provider for that area vide notification no.04/2007 dated 09/04/2007 issued under section 45(1) and 141(2) of The Customs Act, 1962 and the same was extended from time to time till 14.03.2015 vide Notification no. 06/2010 dated 15.03. 2010.

Now, in exercise of the powers conferred on me under Section 45(1) and 141 (2) of the Customs Act, 1962, I, S.H. Hasan, Commissioner of Customs (General), Jawaharlal Nehru Custom House, Mumbai Zone-II, Nhava Sheva hereby appoint M/s. Central Warehousing Corporation to be the Custodian of the imported goods received at the ' Container Freight Station- Logistics Park' until these are cleared for home consumption or are warehoused or are transshipped in accordance with the provision of Chapter VIII of the Customs Act , 1962. Similarly, M/s. Central Warehousing Corporation. will also be the Custodian of the Export Cargo brought into said Container Freight Station for examination and stuffing till their exportation through Jawaharlal Nehru Port.

Further, in exercise of the powers conferred on me under Regulation 10 of the "Handling of Cargo in Customs Areas Regulations 2009". I, S.H. Hasan, Commissioner of Customs (General) hereby approve M/s. Central Warehousing Corporation as a 'Customs Cargo Services Provider' for the CFS Logistics Park subject to following conditions:

1. The Custodian M/s. Central Warehousing Corporation approved as Customs Cargo Services Provider for the said CFS shall abide by all the provisions of The Customs Act, 1962 and the rules of the "Handling of Cargo in Customs Areas Regulations 2009", other regulations, notifications, orders issued there under.
2. The duration of the appointment of M/s. Central Warehousing Corporation as 'Custodian' and as the 'Customs Cargo Services Provider' shall remain for five (5) years from 15.03.2015.
3. The Commissioner of Customs (Export) shall have the Right to review the approval as 'Customs Cargo Services Provider' before the completion of five years for failure to comply with any of the Regulations of the "Handling of Cargo in Customs Areas Regulations 2009 or as per the directions of the Government of India.
