**NOTIFICATION NO. 25/2015**

The area admeasuring 36830 SQM Of Container Freight Station located at Village-Veshvi, Taluka- Post- Dighore, Tal-Uran, Distt. -Raigad., Maharashtra of M/s EFC Logistics India Pvt. Ltd was declared as a 'Customs Area' under Section 8 of The Customs Act, 1962 vide Notification no. 08/2015 dated 12.03.2015 and M/s EFC Logistics India Pvt. Ltd was appointed as a 'Custodian' & 'Customs Cargo Service Provider' for the said CFS area vide Notification no. 09/2015 dated 13.03.2015. Further, an additional area of 1956 SQM was notified as a 'Customs Area' under Section 8 of The Customs Act, 1962 vide Notification 23/ 2015 dated 09.05.2015. Thus the total CFS area becomes 38786 SQM.

Now, in exercise of the powers conferred on me under Section 45(1) and 141 (2) of the Customs Act, 1962, I, S.H. Hasan, Principal Commissioner of Customs (General), Jawaharlal Nehru Custom House, Mumbai Zone-II, Nhava Sheva hereby appoint M/s EFC Logistics India Pvt. Ltd to be the Custodian of the imported goods received at their Container Freight Station admeasuring aprox. 38786 SQM until these are cleared for home consumption or are warehoused or are transshipped in accordance with the provision of Chapter VIII of the Customs Act, 1962. Similarly, M/s EFC Logistics India Pvt. Ltd will also be the Custodian of the Export Cargo brought into said Container Freight Station, including the additional area, for examination and stuffing till their exportation through Jawaharlal Nehru Port.

Further, in exercise of the powers conferred on me under Regulation 10 of the "Handling of Cargo in Customs Areas Regulations 2009". I, S.H. Hasan, Principal Commissioner of Customs (General) hereby approve M/s EFC Logistics India Pvt. Ltd as a 'Customs Cargo Services Provider' for the abovementioned Container Freight Station of M/s EFC Logistics India Pvt. Ltd, including the additional area, subject to following conditions:

1. The Custodian M/s EFC Logistics India Pvt. Ltd approved as Customs Cargo Services Provider for the said CFS shall abide by all the provisions of The Customs Act, 1962 and the rules of the "Handling of Cargo in Customs Areas Regulations 2009", other regulations, notifications, orders issued there under.
2. The duration of the appointment of M/s EFC Logistics India Pvt. Ltd. as 'Custodian' and as the 'Customs Cargo Services Provider' shall remain for five (5) years from the date of issue of the original notification no 09/2015 dated 12.03.2015.

3. The Principal Commissioner of Customs (General) shall have the Right to review the approval as 'Customs Cargo Services Provider' anytime for failure to comply with any of the Regulations of the "Handling of Cargo in Customs Areas Regulations 2009 or as per the directions of the Government of India.
