Subject: Completion of mandatory iGOT Karmayogi courses and Comprehensive Assessment for the APAR cycle 2025–26 – reg.

Reference is invited to D.O. F. No. Pr.DG/NACIN/PSM/36/2026 dated 03.02.2026 issued by the Principal Director General, NACIN, Palasamudram, regarding implementation of the Annual Training Plan on the iGOT Karmayogi platform.

2. In this connection, it is informed that the Comprehensive Assessment Programme for CBIC officers has been made live on the iGOT Karmayogi platform. This assessment is intended to evaluate competencies acquired through prescribed iGOT courses and to confirm completion of mandatory iGOT courses for the reporting year 2025–26. Passing the assessment is mandatory.

3. From the APAR cycle 2025–26 onwards, successful completion will be automatically reflected in the APAR as mandated by DoPT OM dated 04.07.2025, thereby linking learning with performance appraisal and enhancing work efficiency.

4. The designation-wise mandatory courses and courses prescribed for the Comprehensive Assessment are mentioned in Annexure-A of DG NACIN D.O. letter dated 10.09.2025. The assessment includes three courses covering domain, functional and behavioural competencies, which are available on the iGOT dashboard of the concerned officers.

5. Further, as per DoPT OM dated 20.01.2026, the iGOT course titled “Improving Outreach and Communication for Viksit Bharat” has been made mandatory for officers of the level of Deputy Secretary to Special Secretary to the Government of India for the APAR cycle 2025–26. Accordingly, officers above the level of Deputy Secretary / Joint Commissioner are required to complete this course on iGOT by 31.03.2026.

6. All officers under this Zone are therefore directed to log in to the iGOT Karmayogi portal and complete the prescribed mandatory courses and Comprehensive Assessment on or before 31st March, 2026.

7. Supervisory officers shall monitor compliance in respect of officers working under them and ensure timely completion. Non-compliance may have implications on APAR, as per existing instructions.
