MHA letter F. No. 40-3/2020-DM-I(A) dated 24.03.2020 had issued guidelines vide which offices of the Govt. of India, its autonomous/sub-ordinate offices and public corporation shall remain closed for a period of 21 days from w.e.f. 25.03.2020. Addendum to this order was issued on 25.03.2020 in which Customs clearance at ports/airports and land border was exempted in the above clause.

2. Based on further assessment of the situation and in continuation of the Estt. Order No. 10/2020 dated 24.03.2020 further modification are made in Annexure A, B, C, D, E and F in the aforesaid order.

3. The other conditions and directions as specified in the earlier Estt. Order No. 09/2020 dated 23.03.2020 remain unaltered.
