ESTT. OFFICE ORDER No. 30/2020

In terms of GOI, MHA Order No. 40-3/202-DM-1(A) dated 17.05.2020 that lockdown measures continue upto 31.05.2020 to contain the spread of COVID-19, the Government of Maharashtra revised Guidelines No. DMU/2020/CR.92/DisM-1 dated 19.05.2020, the DoPT OM No.11013/9/2014-Estt.A.III dated 18.05.2020, and keeping in view operational requirements and other relevant factors the following is ordered for the time being:

2. The officers/staff as specified in Annexure S, T, U, V, W, X and Y with this Estt. Order shall present themselves in the workplace/office on the respective dates mentioned therein from 23.05.2020 onwards. In addition, the officers/staff that are already working in Sections under respective Shifts Rosters system shall continue to follow those respective Shift Rosters.
3. The rest of the officers/staff (who are not attending the workplace/office on the dates other than mentioned against their name in Annexures S to Y above) of the level up to Dy/Asst. Commissioner shall work from home on relevant dates. During work from home they are required to be available on telephone and with electronic means of communication. They shall attend to/complete the tasks such that substantive part of the work stands attended to and there are no backlogs. They shall also comply the norms set by local administration. They would also attend the workplace/ office when requirement on their part arises for completing the works.
4. The Additional/Joint Commissioner in charge of each Section/Branch/Docks will closely monitor Customs functioning and disposal of work in consultation with the Commissioners to ensure seamless performance of all functions.
5. Every person who is required to attend the workplace/work is to remain conscious of personally observing and ensuring her/his preventive/safety measures and social distancing norm, as well as that of the other person, which include their to and fro, entry/exit, seating, standing, handling, being in queue or during breaks etc.
6. Annexure Z, with this Order, lists officers, from amongst those in Annexure S to Y, who shall also act as guides for social distancing in their respective allotted areas.
7. This is issued in consultation with and with the approval of Commissioner of Customs General/Export, NS-I/Audit, NS-III and NS-V, JNCH, Nhava-Sheva.
