In pursuance of Office Order No. 102/2025 dated 25.07.2025, subsequent Office Order No. 115/2025 dated 07.08.2025 and Office Order No. 122/2025 dated 18.08.2025 issued vide F. No. S/22-Gen-02/2025-26/ASO/JNCH for transfer and posting in the grade of Appraisers of Customs and in pursuance of Office Order No. 108/2025 dated 31.07.2025 issued vide F. No. S/22-Gen-03/2025-26/ASO/JNCH for transfer and posting in the grade of Examiners of Customs, officers transferred/posted in JNCH ought to have been relieved and were expected to join their new place of posting.

- 4. The controlling officers shall forward the leave details of the concerned officers to their next controlling officer subsequently.
- 5. Non compliance of this order shall be treated as insubordination and viewed seriously for further suitable action.
