4. BCBA के द्वारा उठाया गया कार्यबिन्दु /AGENDA POINTS RAISED BY BCBA:

-कार्यबिन्दु संख्या-1/ Agenda Point No.-1 Guidelines for Final Assessment of S/Bills which are Provisionally Assessed in EDI System

We have received feedback from members wherein certain S/bills are provisionally assessed in the EDI system in view of the functionality which has been enabled. We seek clarification on the process for Final Assessment of such Shipping Bills in the EDI System.

प्रतिक्यि।/Response: It was informed that the issue has already been taken up with the DG (System), New Delhi for change in module and the same is likely to be resolved soon.

- कार्यबिन्दु संख्या-2/ Agenda Point No. 2 Congestion at Terminals / Delay in Buffer Movement from CPP causing disruptions in connectivity of Export Consignments

Persistent congestion at terminals and delays in buffer movement are causing significant disruptions in connectivity of Export Consignments. These not only result in additional time taken for Container Gate in but also leads to significant increase in transaction costs. We seek your assistance in exploring solutions for seamless cargo movement for Export Consignments. In the interim, we also request for timely communications from the concerned stakeholders to the trade along with details of extension of vessel cut off and other steps taken to mitigate the same.

प्रतिक्यि। Response: It was informed that Instructions have already been provided to BMCT and other Port terminals to take corrective measures and utilize the free hours optimally by utilizing non-operational entry gates. Trade/stakeholders are also advised to mark the Buffer loaded trucks/trailers with some affixed label /pasting so that such containers can be easily identified and prioritized. The Port Terminals were also instructed to increase necessary infrastructure to handle the growing volume of work. Meanwhile, the CCSP Cell to take up the matter with top officials of port authority for early resolution.

5. CSLA के द्वारा उठाया गया कार्यबिन्दु /AGENDA POINTS RAISED BY CSLA:

- कार्यबिन्द् संख्या-1/ Agenda Point-1: Abandoned Containers:

As mentioned in the previous PTFC meetings too, several thousand containers still remain long standing not only for several months but even years. As per the Board Circular 50/2005, the maximum number of auctions/tenders to which a lot is subjected should be four, with the goods to be necessarily sold to the highest bidder at whatever price received. However, despite this, containers are kept languishing for several years, thereby the cargo losing its value & the containers occupying space at the CFSs. While on the one hand, the shipping lines continue to reposition empty containers into the country at a huge cost to serve the export trade, on the other, these long standing containers continue to be made unavailable to Indian exporters for their export commitments. This not only hits Indian exports adversely but also increases the cost of logistics.

A time limit should be set for the clearance of these containers beyond which, the cargo should be destuffed & the empty containers released to the concerned lines to enable them to allot those boxes for exports.

प्रतिक्रिया/Response: It was informed that there are 683 Containers which are pending for the group NOC. The Disposal Section in coordination with Groups is planning to arrange a 'Group Mela' wherein each group and disposal section will

take the disposal matter on priority with respect to NOCs. The proposed date of Group Mela will be notified soon. The stakeholders are also encouraged to come up with list of pending cases.

- कार्यबिन्द संख्या-2/ Agenda Point-2: SCMT Issues:

Amendment arising due to SCMT system issue to be allowed through simplified way as per board Circular 02 / 2025 – There are few cases where BL Number filed successfully in SCMT which gets disappeared after some time. Thereafter BL does not reflect on ICEGATE. Presently such cases are required to be added in IGM through supplementary / amendment option. The concerned customs department is following strict amendment process for regularizing such amendment cases. There will be few mistakes in initial SCMT filing which was acknowledged by the board circular also. Such cases need to be regularized through simplified process without any fine/penalty

प्रतिक्यि/Response: It was informed that in such cases where the error arises due to system fault, the trade/stakeholder are advised to contact to SCMTR Cell for prompt resolution. In all cases wherein the issue is raised before the arrival of the cargo and evidence showing bonafide mistake from the trade/stakeholders, no penalty shall be levied. Further, cases wherein issue/fault arise due to fault of shipping lines the matter will be viewed seriously. Difficulties faced, if any, may be brought to the notice of concerned AC/DC and senior officials.

- <u>कार्यबिन्दु संख्या-3/ Agenda Point-3</u> Non-generation of SMTP document in SCMT

The SMTP document for Import ICD Containers are still not auto generated. The shipping lines' representatives need to approach customs department for approval of all pending SMTP cases. This is delaying evacuation of import icd containers especially on weekends. This issue needs to be taken up by JNCH with ICEGATE on priority basis.

प्तिकिया/Response: It was informed that this issue has already been taken up to Pr. ADG/DG (Systems) for early resolution.

6. <u>SYLVESTER & CO. के द्वारा उठाया गया कार्यबिन्दु /AGENDA POINTS RAISED</u> BY SYLVESTER & CO.:

-कार्यबिन्दु संख्या-1/ Agenda Point No.-1. Difficulties faced at the time of Export cargo being carted at the CFS.

Off-late the Superintendents of Customs posted at Export Carting CFSs, refer to AN OLD Public Notice 75/2010 dated 28.07.2010 and insisting that all packages if more than one should be numbered 1/300, 2/300, 3/300 etc., despite the Cartons being properly labelled, Batch Numbers affixed and numbered 1,2,3,4 etc.

In 2020 the matter was addressed and accordingly Standing Order was issued. The said matter had been discussed and it was resolved that when the packages are properly marked as per the Marks & Nos shown on the export documents and the packages are numbered which cannot be tampered, the Cargo would be permitted to be carted and in case of any difficulty, the concerned Assistant Commissioner would address the matter

प्रतिक्<u>या/Response</u>: As no representative of M/s. Sylvester & Co. was present during the meeting, this Agenda point was dropped at the request of the trade.
