### **Old Points**

#### **Point No.1:- ICEGATE Facility of Rotation Number of the Vessels:**

It is informed by the trade that some shipping lines/agents are unable to generate Online Rotation Number through the newly implemented ICEGATE option. They have suggested taking up this issue with the ICEGATE/DG Systems for their expert advice.

**Action taken:-**

The Chairman observed that though the point was discussed in the last meeting, no shipping line has come up with the details of specific fields where they are unable to feed the data for generation of the Online Rotation Number. It was directed that concerned Shipping Lines may contact DC/EDI with specific details so that the issue can be taken up with ICEGATE.

**Point No. 2:-EDI Errors, Notification having end use conditions are reflecting BG amount in the Bill of Entry:-**

It is informed that due to EDI System error, Notification having end use conditions are reflecting BG amount in the Bill of Entry.

**Action taken:-**

The Chairman informed that the issue has already been escalated to ICEGATE and DG systems (ICES), New Delhi to resolve the same.

{Point Closed}

**Point No. 3:-Frequent Breakdown of EDI Systems**

It is informed that frequent breakdown of EDI system is detrimental for the timely clearance of import and export consignments.

**Action taken:-**

The Chairman informed that that the connectivity issue has been resolved and of late no instance has been brought to the notice of the Department.

**NEW POINTS**

New Points No. 1 to 3 sponsored by BCBA

**Points No.1:-**

It is raised by the trade that queries raised by Dock Officers are to be discussed with DC docks/Custom Brokers before sending it to group.

**Action taken:-**

The Chairman said that the queries raised by the Docks Officers are invariably forwarded to the concerned Groups through the DC/Docks. In no case, the queries are to be sent directly to the Groups without the approval of DC/Docks. Any specific instance of deviation from the above procedures may be brought to the notice of the Supervisory officers.

{Point Closed}

**Points No. 2:-**

It is informed that RMS Cell insisting for EIR copy for scanning as there is P.No. 26/2017 & 165/2016 for DPD containers.

**Action taken:-**

The Chairman informed the trade that their representation in the matter is being examined and SOP will be developed to ensure smooth clearance of cargo without compromising the purpose of scanning of containers.

(Action: ADC/RMS Facilitation Cell)

**Points No. 3:-**

It is informed by the trade that some importers had re-imported shipment and Bill of Entry was filed under the provisions of Notification No. 446/2017 Sr, 1 (d) on 1<sup>st</sup> August, 2017 by virtue of which amount of Central Excise duty not paid at the time of export is to be paid.

However, they have given to understand by the proper officer of Customs that EDI System is capturing IGST against Notification No. 46/2017 Sr. 1 (d).

**Action taken:-**

The Chairman informed that the issue raised by the trade has been taken note of and the matter is being taken up with the ICEGATE.

(Action: ADC/EDI)
