2. At the outset, the Commissioner of Customs, NS-V, Shri V. S. Chauhan welcomed all the members and informed in brief about the salient points arising out of the Time Release Study 2018. Copies of the same were distributed to all trade members. The agenda points relating to

Import Commissionerate were discussed first, and then following agenda points of the Export/General Commissionerates were deliberated upon.

NEW POINTS

Point No. 1: Simplification of EGM Procedures:-

<u>Request:</u> MANSA has represented that presently, EGM is filed in two ways: A) through EDI in ICEGATE and B) through Hard copy manually. For filing Hard copy EGM, the Shipping Line has to get endorsement of the Preventive office on each S/Bill, by producing copy of Mate Receipt prepared for each container, compile them and then enclose it with hard copy EGM filed. As per attached PN 150, this procedure is now stopped in case of local F/S containers, however in case of ICD the procedure is still followed. One T/R copy is submitted along with EGM in ECU, Dnode and one set is handed over to the Preventive office for further dispatch to the ICD locations. This is in addition to the EGM submitted in EDI format. Since now EDI EGM for ICD containers is also filed and is already available in the ICEGATE/Customs systems. This process should be scrapped for ICDs as well as per the PN, as this only help in increasing work load the piling up of papers.

Status: Vide circular No. 56/2016-cus dated 24/11/2016 it has been provided that in case of containerized cargo, issuance of mate receipt would no longer be required. As requirement of mate receipt has been done away with, the endorsement of transference copy, which was done on the basis of mate receipt does not seem to be required. Also EGMs for ICDs containers are being filed in Customs EDI system. Therefore, in this era of "ease of doing business", the endorsement of transference copy does not seem to be required.

Discussion:-It was discussed and observed that subsequent to issuance of circular No. 56/2016cus dated 24/11/2016, the issue is already clarified.
