The monthly meeting of Permanent Trade Facilitation Committee (PTFC, Export) was held on 23-09-2016 at 11.30 AM in the Conference Hall at 7th Floor of the Jawaharlal Nehru Custom House. The meeting was chaired by Shri Shrawan kumar, Commissioner of Customs, NS-III, Shri Vijay Singh Chauhan, Commissioner of Customs, NS-V, Shri Subhash Agrawal, Commissioner of Customs, NS-IV & General and Shri M.R. Mohanty, Commissioner of Customs, NS-II.

- 4. At the outset, the Chairperson welcomed all the members and directed to start the deliberations on the agenda of the meeting. The agenda relating to Import Commissionerate were discussed first, and then following agenda of the Export Commissionerate were deliberated upon
- 5. Thereafter, the Agenda points were taken up for discussion. The following old point from the last PTFC meeting held on 25.08.2016 was taken up for discussion:

<u>Point No. 1:</u> Transmission of Advance Authorization License with convertible currency and INR.

Background: The trade in the earlier PTFC meeting held on 25.08.2016 submitted that BCHHA had made a representation to System Directorate, New Delhi, regarding hardship being faced by Exporters for transmission of Advance Authorization License with convertible currency and INR on Customs EDI System. In this regard, they had received a reply from Mr R. Anath, Deputy Director, Director General (System), stating that necessary changes have been incorporated on 28-06-2016 in the EDI System in consultation with DGFT. However, it is being experienced that the changes have still not been incorporated in the EDI System. They have requested to look into this matter and represent with Directorate of System to effect the necessary changes as follows:

- a) Debit Foreign Currency only in the License, from overall value of license and stopping of INR debits as is stipulated in Handbook of Procedure 2015 -2020 in Para 9.01 (C).
- b) Only quantity should be debited on individual item level instead of value in terms of para 4.26 (C), which states an Advance Authorization shall inter-alia specify aggregate CIF Value of Imports.

Earlier Discussion: The members were informed that the matter is being taken up with Directorate of Systems for incorporation of necessary changes in this regard and also advised them to pursue the matter directly with Directorate of Systems in their individual capacity.

Present Discussion: DC/EDI vide letter dated 20.09.2016 replied that they have already referred the matter to the Directorate of the Systems and Data Management, New Delhi alongwith letter received from M/s BCHAA, for necessary action. Matter is under consideration of DG Systems.

This point is also included in the agenda points and minutes of the Appraising Main (Import). Therefore, this point may be closed at this end.

NEW POINTS

Point No.2: Ms. Roshan Irani of M/s Shy Shipping raised the issue that Mate Receipt is demanded for passing E.P. Copies. M/s BACHAA had earlier raised this issue vide letter dated 21.07.2016, requesting to do away with requirement of Mate Receipt for passing EP copy. If the details shown in the EGM matches with the details of the S/Bill in EDI system, then only EP copy is generated. Therefore, it is submitted by them that there is no need to physically check the Mate Receipt if the Container is actually On-Board the Vessel.

Discussion: Mate receipt and Bill of Lading, being a proof of export, issued by the Shipping Lines, are mandatory document required for removal of 'C', 'L' and 'N' of EGM Errors. Mate Receipt is document signed by an officer of a vessel evidencing receipt of a shipment onboard the vessel. On the basis of Mate receipts only, EGM errors viz. C, L and N are removed after proper verification. However, it was decided to examine the issue.

(Action: DC/EGM Co-ordination Cell)

Point No.3: Ms. Roshan Irani of M/s Shy Shipping raised the issue that H-Card clerks are not allowed to take examine and delivery of the Cargo. Preventive officers posted at the gates ask for G-Card holder at the time of releasing the trailors.

Discussion: As per Para 4.2 of Board Circular No.09/2010-Customs, issued vide F.No. 502/5/2008 – Cus. VI dated 08/04/2010, authorized signatory for the documents is "G" category pass holder. CHA employee possessing "H" card can only assist the CHA in his work, so he cannot be allowed to take examine and delivery of the Cargo.

Trade has submitted that it is not viable for them to send "G" card holder for each and every work. There are not many employees under a license holder having "G" category pass and they have to pay more to hire them and requested to allow "H" card holder to allow delivery of the cargo. Trade has been advised to make representation.
