- 4. At the outset, the Chairperson welcomed all the members and directed to start the deliberations on the agenda of the meeting. The agenda relating to Import Commissionerate were discussed first, and then following agenda of the Export Commissionerate were deliberated upon
- 5. Thereafter, the Agenda points were taken up for discussion.

### **NEW POINTS**

### **Point No. 1: MEIS Shipping Bill Transmission problem**

**Background:** BCHAA has referred DGFT PN No. 47/2015 dated 08.12.2015 wherein it was decided by DGFT that all the Shipping Bills where the scheme box has not been ticked as ( ) in the Shipping Bill, shall be transmitted by CBEC to DGFT for the period 01.04.2015 to 30.09.2015. However, as per information gathered from trade / their members, the transmission of Shipping Bills have not taken place as required. As the transmission has still not commenced, they have requested to issue a PN in this regards for the benefit of Trade.

**Discussion:** The members were informed that all the shipping bills where declaration of intent "Y" has not been marked and "N" has been ticked inadvertently in the 'reward item box' while filing shipping bills in Customs for exports made between 01.06.2015 to 30.09.2015, shall be transmitted by CBEC to DGFT. In the case of non-transmission of Shipping Bill to DGFT, the individual cases may be brought to the notice of JNCH so that list of such

Shipping Bills may again be provided to System Directorate.

Point No. 2: Transmission of Advance Authorization License with

convertible currency and INR.

Background: BCHHA had made a representation to System Directorate,

New Delhi, regarding Hardship being faced by Exporters for Transmission

of Advance Authorization License with convertible currency and INR on

Customs EDI System. In this regard, they had received a reply from Mr R.

Anath, Deputy Director, Director General (System), stating that Necessary

changes have been incorporated on 28-06-2016 in the EDI System in

consultation the DGFT. However, it is being experienced that the changes

have still not being incorporated in the EDI System. They have requested

to look into this matter and represent with Directorate of System to effect

the necessary changes as follows:

a). Debit Foreign Currency only in the License, from overall value of

license and stopping of INR debits as is stipulated in Handbook of

Procedure 2015 -2020 in Para 9.01 (C).

b). Only quantity should be debited on individual item level instead of

value in terms of para 4.26 (C), which states an Advance Authorization

shall inter-alia specify aggregate CIF Value of Imports.

**Discussion:** The members were informed that the matter is being taken up

with System Directorate for incorporation of necessary changes in this

regard and also advised them to pursue the matter directly with System

Directorate in their individual capacity.

(Action: BCHAA & DC/EDI)

Point No. 3: Removal of mandatory warehousing requirements for EOUs,

STPIs, EHTP etc.- Amendment to Notification 52/2003- Customs dt.

31.03.2003.

Background: BCHAA has brought notice on the major impetus for Make in

India, as CBEC has announced landmark reforms in 100 % EOUs, STPIs, EHTPs

schemes 100 % EOUs, STPIs, EHTPs schemes vide Circular no. 35/2016 -

Customs dated 29-07-2016. They have requested to operationalize the said CBEC

Circular and issue a PN on urgent basis giving point wise operating procedure as

per the new CBEC Circular.

**Discussion:** The members were informed that the Public Notice No. 111/2016

and Standing Order No. 47/2016 both dated 19.08.2016 have already been issued

by Commissioner of Customs NS-IV in this regard and available on JNCH

website.

**Point No. 4:-** Abnormal charges for issuance of DO for LCL cargos

Shipping Companies are levying abnormal charges for issuance of DO for

LCL cargos under various heads which often equal or even more than DO

charges for clearance of FCL cargos. This leads to exploitation of importers.

M/s Bombay Metal Exchange Ltd. has requested to standardize or regulate

appropriate levies as per tonnage.

**Discussion:** It was advised to come with specific details of such cases of non-

transparent abnormal charges levied by Shipping Lines and to raise the matter

raised in next CCFC.

(Action: CCO& M/s Bombay Metal Exchange Ltd.)

**<u>Point No. 5</u>**: Container Damage Charges.

Many times shipping lines exploit importers by penalizing them for

damaged container at the time of returning the containers, even if it's not his

fault. Who knows if the container was already damaged at the handing over

for de-stuffing.

**Discussion** It was advised to come with specific details of such cases of

transparent abnormal charges levied by Shipping Lines and to raise the matter

raised in next CCFC

(**Action:** CCO& M/s Bombay Metal Exchange Ltd.)

Point No. 6: CFS are charging Transport as well as Fuel Charges: Under

what pretext are these charges being levied?

**Discussion:** The members were advised to give representation having specific details, so that the matter may be taken up with M/s CFS Association of India.

(**Action:** M/s Bombay Metal Exchange Ltd)

### **Point No. 7:** - Weigh Bridge calibrations by CFS.

**Background**: Weigh Bridges are not standardized and there is an inconsistency in weights due to improper maintenance and management. This discrepancy in weighing results in a shortage which is actually not there but which is sent to the buyer who sometimes rejects the consignment / and or makes a short payment. A penalty should be imposed on discrepant weigh bridges and the CFS should be made liable for this lapse.

**Discussion -** It was informed that concern of member will be addressed, however for taking any action against CFS, specific input is needed. In periodical inspection of CFSs, proper Weigh Bridge calibrations and maintenance is also important criteria. These cases will also be referred to department of Weight and Measurement.

**Action:** (DC/CFS Management Cell, **M/s** CFS Association of India & M/s Bombay Metal Exchange Ltd.)

Point No.8: At JN port CFSs play a important role in clearance both for Import and Export. For quite some time the PTFC meetings are discussing issues connected with overcharging and other unhealthy practices being followed by some CFSs. It was informed that such issues are also discussed at the port CCFC meetings. But it seems not much headway is being made. It was suggested that the Chief Commissioners be armed with proper powers to impose heavy penalties on such recalcitrant CFSs. It was also desired that the Minutes of such CCFCs be mailed to the members of the PTFCs so as to enable the trade to move other ministries correlated to foreign trade in order to seek proper solution to this very major hurdle/problem which is hindering the smooth working of the country's foreign due to the usurious practices of some CFSs.

**Discussion:** The members were informed that the minutes of CCFCs and PTFCs are uploaded on JNCH website periodically. One can easily assess these minutes for one's reference. Directions were also given to email the minutes to the email address provided by representative.
