- 4. At the outset, the Chairperson welcomed all the members. The Chairperson also informed about the re-constitution of the PTFC and extended warm welcome to all the new members joining the PTFC meeting for the first time. Thereafter, the Chairperson introduced the newly joined departmental Officers to all the members.
- 5. Thereafter, the Agenda points were taken up for discussion.

OLD POINTS

(a) Post Shipment Amendments under Section 149 in MEIS Shipping Bill.

Background: This point was discussed in last PTFC meeting. Many Exporters are facing problem due to technical problem in getting amendments transmitted.

Customs is required to issue certificate to Exporters to fulfil the requirements with respective authorities like DGFT / Central Excise / Bank etc.

BCHAA has also given representation to DGFT and System directorate vide their letter dated 10.06.2016 for transmission of Shipping bills to DGFT for period up to amendment in Handbook para for MEIS and requested as under:

- 1) Trade would highly appreciate, if the DGFT and System Directorate would transmit Shipping bills for the period 01.04.2015 to 16.05.2016, as the respective para 3.14 if Handbook is amended vide above Public Notice.
- 2) There were many technical lapses in filing Shipping bills as Exporters / Custom Broker were not aware to tick mark each item for MEIS benefits, hence in many of the cases either Shipping bills are marked 'y' but not for all items of invoices hence not getting transmitted.
- 3) Also, there are many case, where Text intent as per para is given, but either 'y' ticked or being missed out.
- 4) Customs can issue amendment letter to this effect, as there is Technical limitations to transmit such Shipping bills to DGFT.

Accordingly, Customs was requested to pursue the matter with respective authorities to help trade getting their benefit.

Discussion: It was informed that post shipment amendments are technically not being allowed to transmit in 1.5 ICES. After filing the EGM the data is shared with DGFT and details of Shipping Bills are transmitted to DGFT and after this transmission the data is frozen in ICES and no further changes/amendments are possible. It was further informed that the Custom would be issuingthe certificate endorsing export of goods on case to case basis & on merits, whenever the department will be approached with proper documents. He also assured that such request will expeditiously be disposed off and for the same, all concerned are being sensitized.
