The Annual Maintenance Contract is comprehensive including repair and replacement of defective parts, no separate bills will be submitted by the service provider for any hardware repairing or replacing pertaining CCTVs systems.
- 2. Tenderers will do the following before implementation -
 - (a) Conduct a detailed study of the requirements and perform a site survey.
 - (b) Examine and determine the requirements.

3. Implementation -

- (a) Successful Tenderers will be responsible for the complete maintenance of CCTV systems including cameras and workstations configuring and providing assistance to the personnel in understanding and operating the system. Diagnose the faults and rectify the defect detected within 24 hours.
